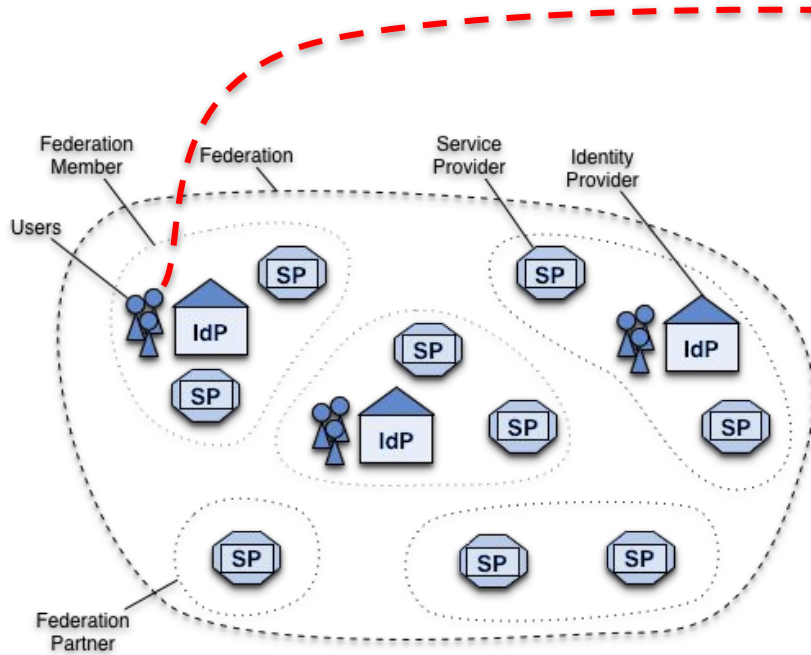

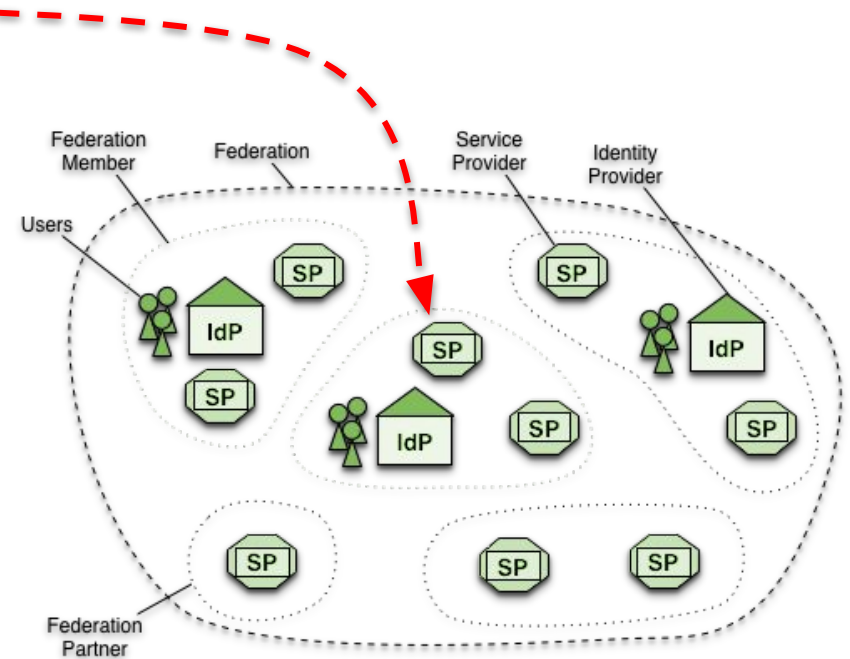

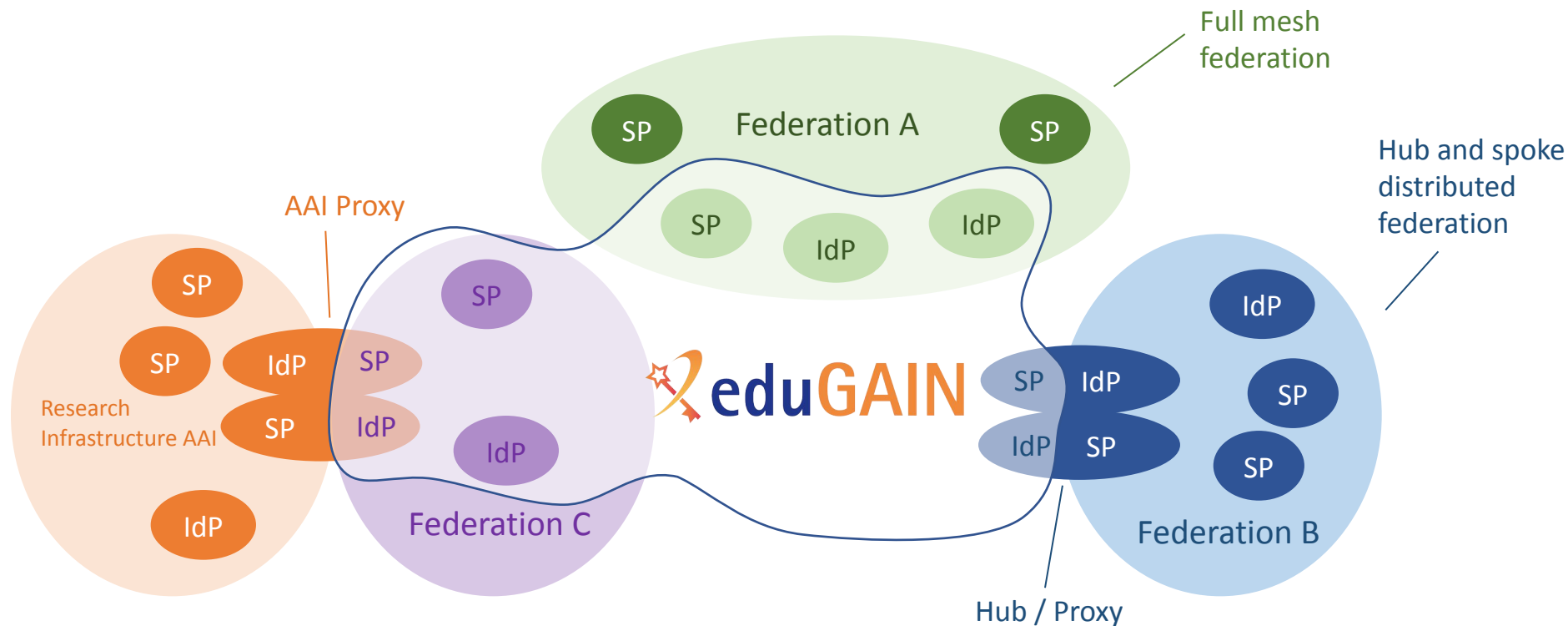


Federation Blue

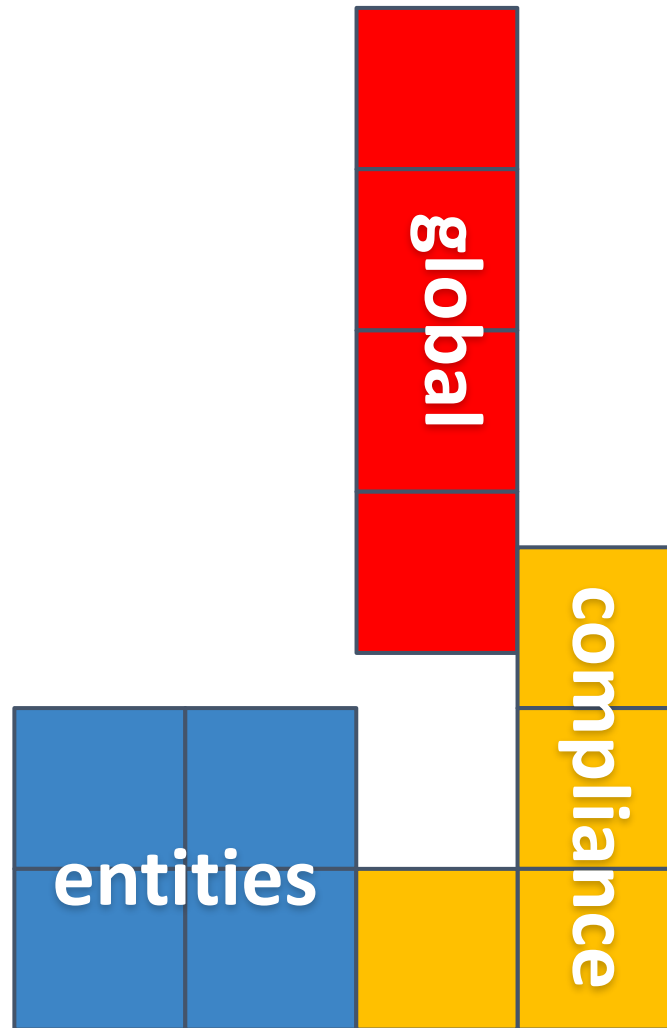

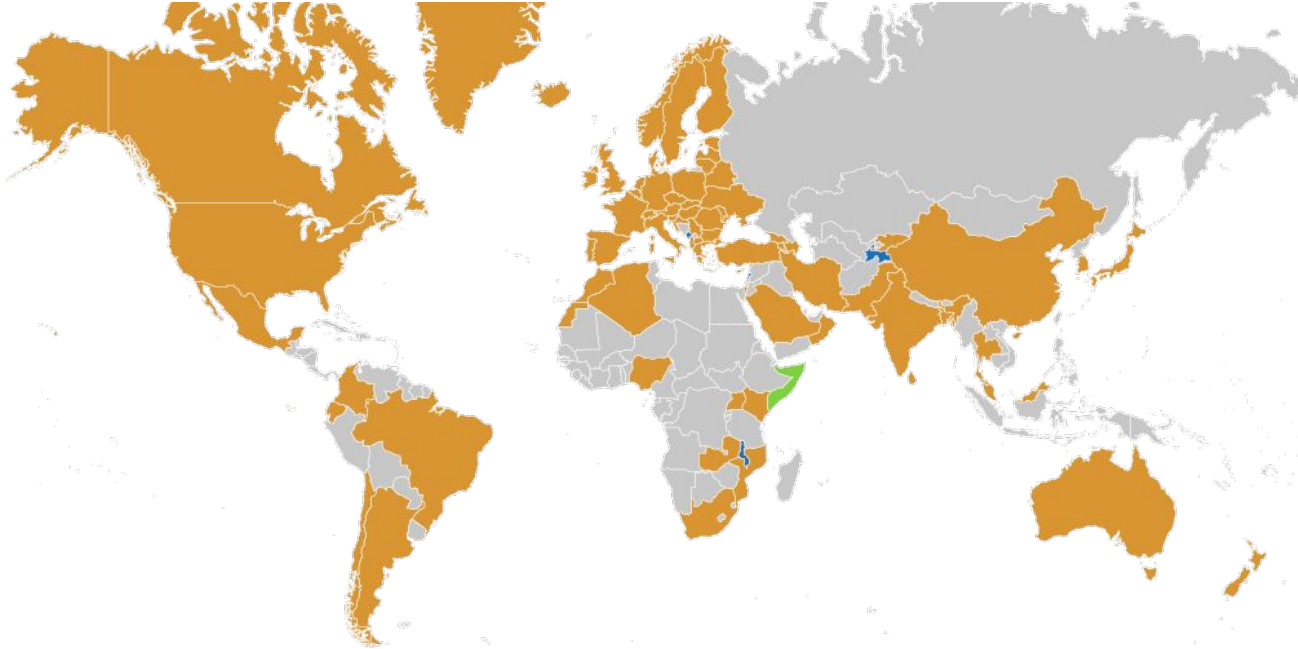

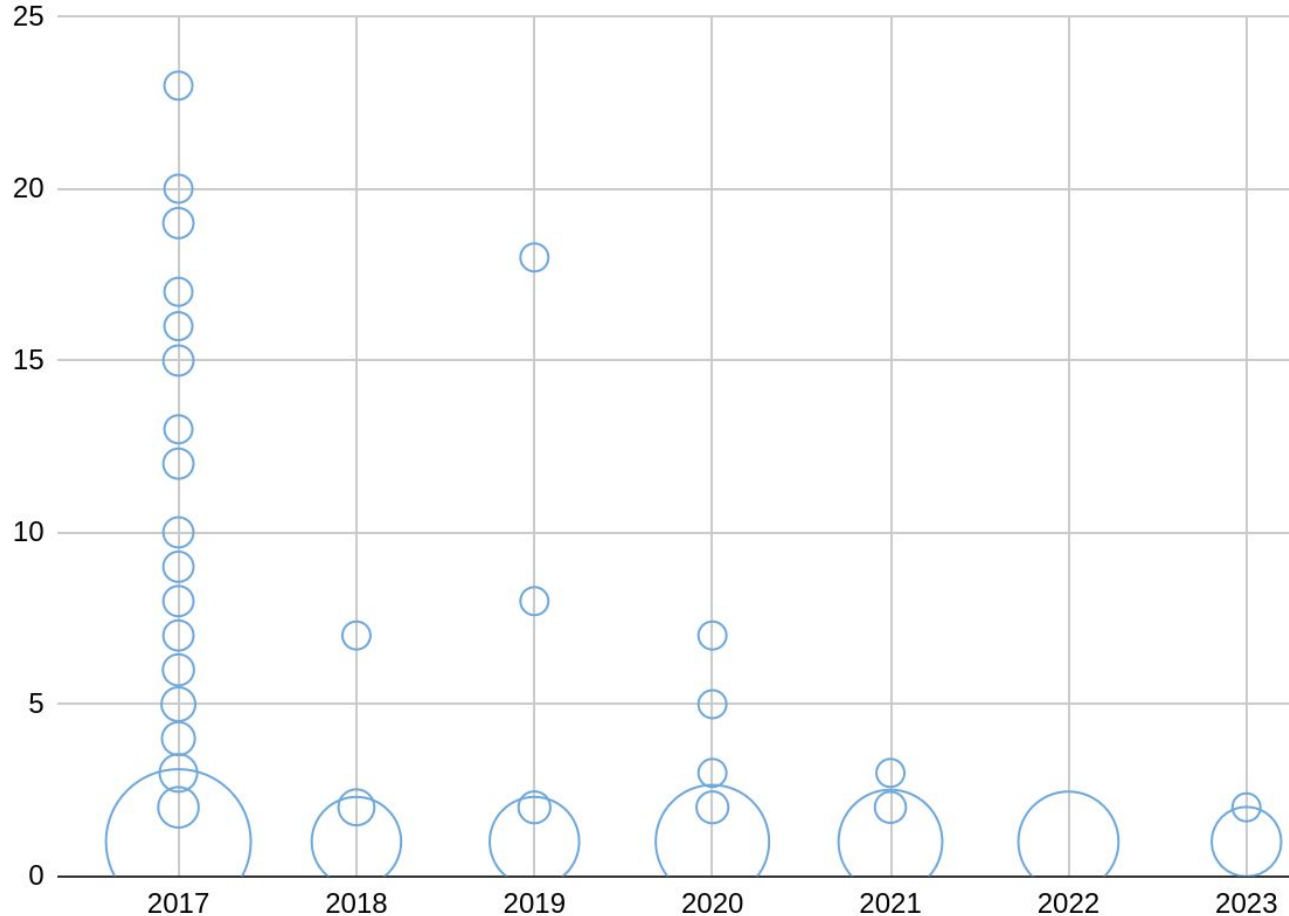

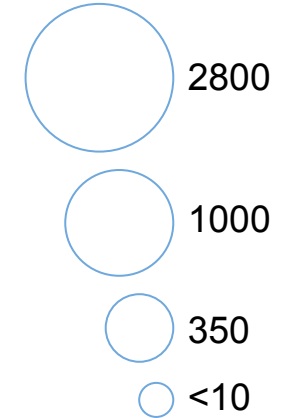

eduGAIN Futures WG Problem Statements

01	Complex service experience	<ul style="list-style-type: none">• Almost 9000 entities• Service experience varies wildly
02	Unpredictability	<ul style="list-style-type: none">• Information exchanged between IdP A and SP B?• Hard to rely on eduGAIN without predictable outcome
03	Diverse policies and processes	<ul style="list-style-type: none">• Federations have their own policies and processes• Interaction with eduGAIN/participants is often inconsistent
04	Variable service offerings	<ul style="list-style-type: none">• Differences in funding, staffing and service level• Service offerings varying accordingly
05	Slow response to change	<ul style="list-style-type: none">• Entities and Federation Operators are often slow to adopt changes to security standards and policy requirements
06	Delays in decision making and new Technologies	<ul style="list-style-type: none">• EduGAIN itself is slow in taking decisions and embracing new technologies
07	Unclear mission and branding strategy	<ul style="list-style-type: none">• Mission, role and brand of eduGAIN are unclear, leading to different expectations

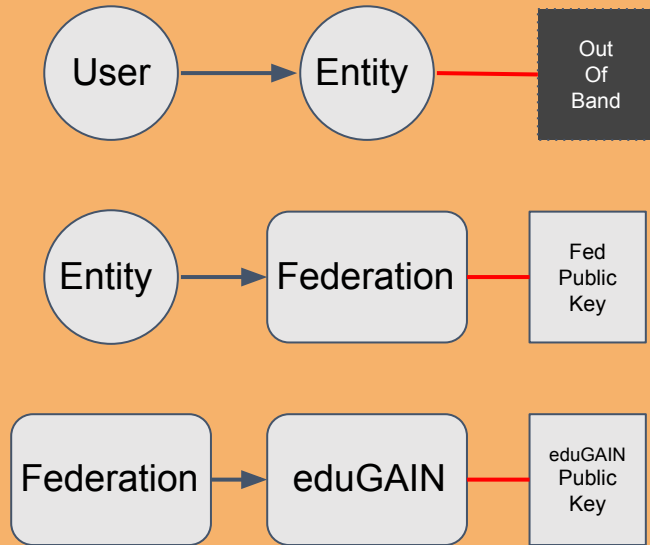

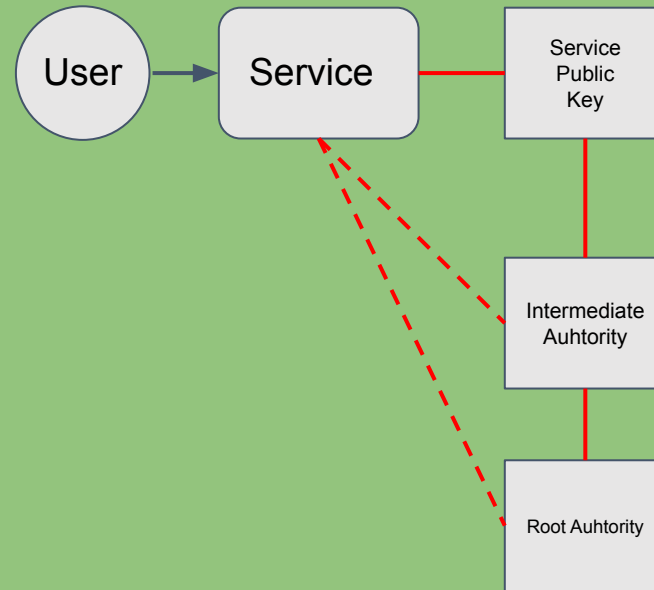
